


Stage #1 - STARDUST



START POSITION: Sitting on chair outside the shooting area, both hands on knees.

GUN READY CONDITION: Handgun - chamber empty. PCC - Option 2

SCORING		RULES
ROUNDS: POINTS: PAPER TARGETS	16 80	A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.
IPSC:	0	If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as
USPSA:	7	above. No penalty is assessed if a competitor does not
POPPERS:	2	fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting
PLATES:	0	area is required to re-establish presence in a shooting area.






Stage #2 - SLOW DOWN



START POSITION: Standing outside the shooting area, both heels touching mark.

GUN READY CONDITION: Handgun loaded and holstered. PCC loaded - Option 1

SCORING		RULES
ROUNDS: POINTS: PAPER TARGETS	30 150	A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.
IPSC:	0	If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as
USPSA:	12	above. No penalty is assessed if a competitor does not
POPPERS:	6	fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting
PLATES:	0	area is required to re-establish presence in a shooting area.






Stage #3 - HEAD HUNTER



START POSITION: Standing outside the shooting area, both heels touching mark.

GUN READY CONDITION: Handgun loaded and holstered. PCC loaded - Option 1

SCORING		RULES
ROUNDS: POINTS: PAPER TARGETS	22 110	A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.
IPSC:	0	If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as
USPSA:	8	above. No penalty is assessed if a competitor does not
POPPERS:	3	fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting
PLATES:	3	area is required to re-establish presence in a shooting area.






Stage #4 - MadMax



START POSITION: Standing inside the shooting area, both heels touching mark.

GUN READY CONDITION: Handgun loaded and holstered. PCC loaded - Option 1

SCORING		RULES
ROUNDS: POINTS: PAPER TARGETS	24 120	A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.
IPSC:	0	If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as
USPSA:	11	above. No penalty is assessed if a competitor does not
POPPERS:	2	fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting
PLATES:	0	area is required to re-establish presence in a shooting area.






Stage #5 - PARKING LOT



START POSITION: Standing anywhere in designed area.

GUN READY CONDITION: Handgun loaded and holstered. PCC option 1

SCORING		RULES
ROUNDS: POINTS: PAPER TARGETS	25 125	A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.
IPSC:	0	If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as
USPSA:	12	above. No penalty is assessed if a competitor does not
POPPERS:	1	fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting
PLATES:	0	area is required to re-establish presence in a shooting area.






Stage #6 - NAME HAVE BEEN CHANGED



START POSITION: Standing Outside the shooting area, both heels touching mark.

GUN READY CONDITION: Handgun loaded and holstered. PCC loaded, option 1.

SCORING		RULES
ROUNDS: POINTS: PAPER TARGETS	18 90	A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.
IPSC: USPSA: POPPERS: PLATES:	0 8 2 0	If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as above. No penalty is assessed if a competitor does not fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting area is required to re-establish presence in a shooting area.





Stage #7 - HARD DAY



START POSITION: Standing Outside the shooting area, both heels touching mark.

GUN READY CONDITION: Handgun loaded and holstered. PCC loaded - Option 1

STAGE PROCEDURE: Upon start signal, engage targets from within the fault lines.

RULES

A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.

If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as above. No penalty is assessed if a competitor does not fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting area is required to re-establish presence in a shooting area.






Stage #8 - GEAR UP FOR



START POSITION: Standing Outside the shooting area, both heels touching mark.

GUN READY CONDITION: Handgun loaded and holstered. PCC option 1

SCORING: COMSTOCK		RULES
ROUNDS: POINTS: PAPER TARGETS	24 120	A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.
IPSC:	0	If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as
USPSA:	11	above. No penalty is assessed if a competitor does not
POPPERS:	2	fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting
PLATES:	0	area is required to re-establish presence in a shooting area.






Stage #9 - FIRE ON



START POSITION: Standing on mark inside the shooting area.

GUN READY CONDITION: Handgun loaded and holstered. PCC loaded, option 1.

SCORING : COMSTOCK		RULES
ROUNDS: POINTS: PAPER TARGETS	15 75	A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.
IPSC: USPSA: POPPERS: PLATES:	0 7 1 0	If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as above. No penalty is assessed if a competitor does not fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting area is required to re-establish presence in a shooting area.





Stage #10 - "CM 09-08 Crackerjack"



START POSITION: Standing centered in the shooting area, hands on the marks.

GUN READY CONDITION: Handgun loaded and holstered. PCC loaded, option 1.

SCORING: COM	ISTOCK	RULES
ROUNDS: POINTS: PAPER TARGETS	12 60	A shooter who fires shots while completely outside (both feet out and touching the ground) a shooting area is deemed to have gained a significant advantage and will be given one penalty for each shot fired until presence is reestablished in a shooting area.
IPSC: USPSA: POPPERS: PLATES:	0 6 0 0	If a competitor starts and fires shots while completely outside a shooting area, foot fault penalties will apply as above. No penalty is assessed if a competitor does not fire any shots while faulting. Having at least one foot in a shooting area and nothing touching outside the shooting area is required to re-establish presence in a shooting area.
